The purpose of this Local Law to amend Chapter 260 is to clarify development and other standards for the Scenic Overlay to better protect these environmentally sensitive areas in the Town of Woodstock. The current law contains ambiguities that have led to uncertainty on the part of scenic overlay home owners and developers regarding scenic overlay standards, and unclear direction to Town of Woodstock departments, boards, and committees regarding Scenic Overlay enforcement. These Chapter 260 updates provide clarity and remove ambiguities in the law to help with Scenic Overlay law understanding, adherence, and enforcement.
