

This designation is in recognition of the importance of the upland forests, shrub lands, meadows, forested swamps, vernal pools, ponds, marshes, wetlands, small streams and a portion of the Sawkill stream located in the area. The proposed CEA designation would aid landowners in the planning stages of development of their property so as to minimize damage and disturbance to this geographic area.
