MESSAGE FROM THE SUPERINTENDENT AND BOARD PRESIDENT

Proposed 2020-2021 School Budget Within Tax Levy Limit

Proposal Developed in Climate of Economic Uncertainty

DEVELOPING A PROPOSED BUDGET DURING THIS TIME OF UNCERTAINTY HAS BEEN CHALLENGING. The level of State Aid, which helps offset the local tax impact, is still unknown. We also do not know what opening school in September will look like, and how any potential requirements will increase our expenses. "With so much uncertainty before us, we were challenged to make decisions based on unknown factors," explained Superintendent Victoria McLaren. "To do so, we kept our discussions and decisions centered on what would be best for students, while balancing potential future cuts in State and Federal Aid and taxpayer impact."

As a result, the Onteora Board of Education adopted the 2020-2021 proposed budget, which holds the spending increase to less than 1 percent (0.93 percent) and meets the criteria of the NYS tax levy limit (tax cap) formula, which permitted a 2.56 percent levy increase. This is the ninth year in a row that Onteora has presented a budget at or below the allowable tax levy limit. The \$57,938,542 plan will be voted upon by absentee ballot this year, with all completed ballots due to be returned to the Office of the District Clerk by 5 PM on June 9, 2020. Reflects Reduced Spending in Some Areas

In addition to reductions in the areas of operations and maintenance, transportation, and general support, the proposed budget reflects savings in the area of debt service, as Onteora paid off the balance due on a bus purchase.

Continues Support for Pre-Kindergarten Programs

Onteora will continue to provide a strong foundation for children to begin their educational journeys by continuing to support both half-day and full-day Universal PreKindergarten (UPK) programs.

Maintains Infrastructure

The proposed budget also invests \$750,000 in fund transfers to support two ongoing building improvements, one involving the replacement of the air-handling unit over the Bennett Elementary School gym, and the other focusing on resurfacing the High School tennis courts and paving various areas within the District.

Addresses Potential Cuts in Aid

At this time, the amount of State Aid school districts can expect is unknown, as is the amount of Federal Aid, so Onteora is preparing for various fiscal scenarios. New York State Comptroller Thomas DiNapoli has warned that school districts may be facing a 20 percent reduction in State Aid. "The State is using quarterly measuring

Chromebooks and Technical Support for At-Home Learners

ONCE ONTEORA'S PHYSICAL SCHOOLS SHUT THEIR DOORS, teachers had to quickly design lessons that could be delivered remotely, and families had to carve out learning spaces in their own homes.

To facilitate that abrupt transition, Onteora distributed approximately 300 Chromebooks to students in Grades K-8. Students in these grade levels had previously used District-issued computers only in their classrooms. (High School students had been allowed to take their Chromebooks home nightly throughout the school year and so had their devices with them when the school closure went into effect.)

The District has also created a Google Form to provide students, parents, and faculty members across all grade levels remote technical support during the closure. This form can be found by going to the District website (<https://www.onteora.k12.ny.us>), then clicking on the Remote Learning - Technical Support - Form tab on the right hand side of the screen. Technical Support team members can only offer assistance for District platforms, applications, and devices, but will do their best to answer any questions you may have.

ONTEORA'S MUSICIANS PLAY ON

periods to decide how much aid districts may lose," said Onteora's Assistant Superintendent for Business, Monica Kim LaClair. "To help preserve instructional programs, we are recommending to the Board of Education that any savings realized from the closure of our buildings in March—including reduced costs for fuel, electricity, field trips, conferences, and other reduced expenditures—be carried over into next year in order to help to offset potential State Aid cuts as predicted by Governor Cuomo," she added.

Contingent Budget

As of publication of this newsletter, Governor Cuomo has not yet provided information to schools on what a failed budget vote would mean. In the past, a district would have one additional chance to present a new budget to voters for approval. Since the school's fiscal year begins on July 1, there is no time for a second vote. If Onteora's proposed budget fails, officials presume the District would need to go straight to a contingent budget, which would require a zero percent tax levy increase from the 2019-2020 school year and result in cuts totaling \$1,117,748. A contingent budget would eliminate all equipment purchases from the budget. There would also be reductions in areas such as field trips, conferences, and non-mandated services. "Any decisions about budget cuts will be student-based, and will focus on providing the maximum amount of support for our students when they return to our buildings as possible," said Superintendent McLaren. "This pandemic has impacted our students and their families in many ways, and we will continue to do our best to provide as much academic and social emotional support for them as we are able."

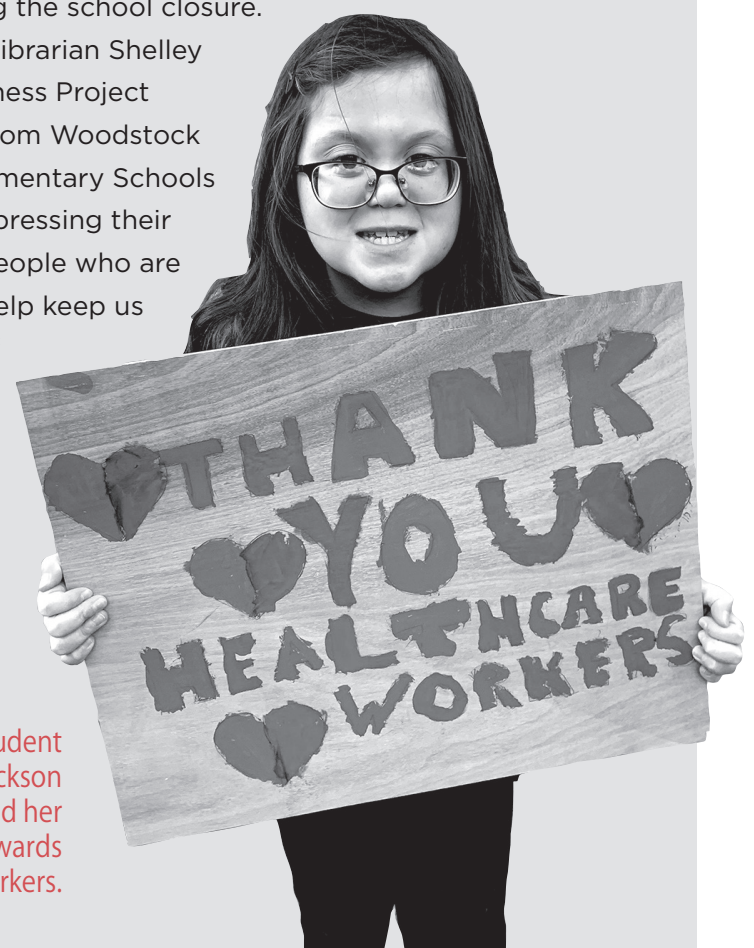

SIGNS OF THE TIMES: Elementary School Students Honor Community Heroes

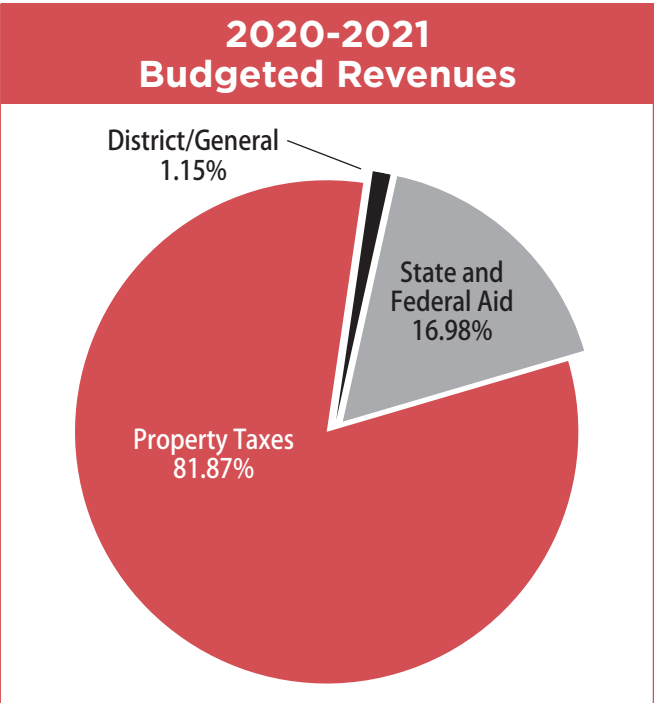
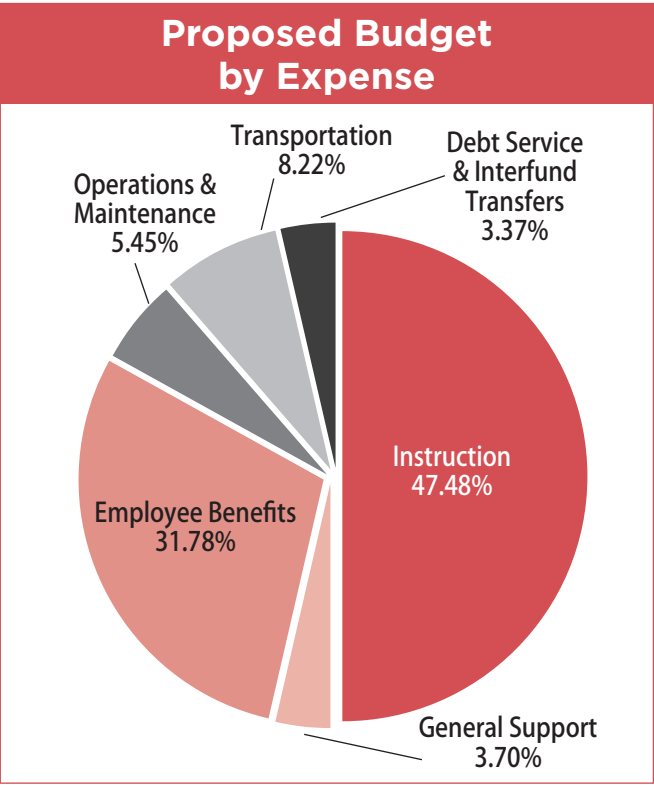

WHAT YOU WILL SEE ON THE BALLOT

PROPOSITION # 1 – 2020-2021 BUDGET
BE IT RESOLVED, that the Onteora Central School District Board of Education be and is hereby authorized to expend the sums set forth under the various headings which are voted upon in gross and not in detail in the total amount of \$57,938,542 (which includes \$20,000 to support public library) for the year commencing July 1, 2020 and ending June 30, 2021, and the Board is authorized to levy and collect the necessary tax thereof on the taxable property of the District.

Questions & Answers About Voting

Will There Be In-Person Voting? As ordered by the Governor, voting will be by **absentee ballot only**. All “qualified voters” are eligible to vote and receive an absentee ballot. All completed absentee ballots must be received in the Office of the District Clerk by 5 PM on June 9, 2020 to be counted.

Am I Eligible to Vote? In order to be eligible to vote, you must be at least 18 years of age, a U.S. citizen, a resident of the Onteora Central School District for at least 30 days prior to the vote, and not otherwise prohibited from voting under the provisions of Section 5-106 of the Election Law (e.g. a person who had been adjudged to be mentally incompetent).

How Do I Receive My Absentee Ballot? All voters who are registered to vote with the County Board of Elections will automatically be sent an absentee ballot, a postage-paid return envelope, and instructions. Information on how to determine if you are a registered voter and how an unregistered voter, who meets the definition of a qualified voter, may receive an absentee ballot is available at: <https://www.onteora.k12.ny.us/board-of-education/vote-election>. BENNETT JOURNALISTS LEARN THE ART OF FEATURE WRITING

JOURNALISM IS THE FOCUS of an innovative learning experience at Bennett Elementary School.

Before the school closure, Grade 5 students and teachers began collaborating with the Teachers College Reading and Writing Project at Columbia University to pilot a new section in the writing project’s journalism study unit. The section, called a “bend,” is focusing on feature articles.

According to Grade 5 teacher Karen Hadley, the students’ work is being guided by the question, “How Do Humans Impact the Earth?” Working in collaborative research groups, the fledgling journalists launched investigations into the following topics: endangered species, coral reefs, ocean pollution, climate change, and deforestation.

As research progressed and writing began, students approached their topics from different angles. For example, one student in the deforestation group chose to zoom in on clear-cutting in the Amazon, while another is focusing on Australian wildfires.

According to Ms. Hadley, the students are also highlighting ways that humans are helping to stop environmental damage and to reverse negative trends impacting our planet. “The soon-to-be-published articles will be compiled in an online magazine format,” she explained. “The magazine will include many text features such as hand-drawn illustrations, sidebars, graphs, maps, timelines, and word banks.”
