2020-2021 Proposed Budget

- 2019-2020 Budget \$57,403,498
- 2020-2021 Budget \$57,938,452
- Increase of \$535,044 or .93%
- Appropriated Fund Balance
 - \$2,515,620- Appropriated Fund Balance to reduce tax levy
 - \$750,000 – Fund Balance to offset additional Capital work

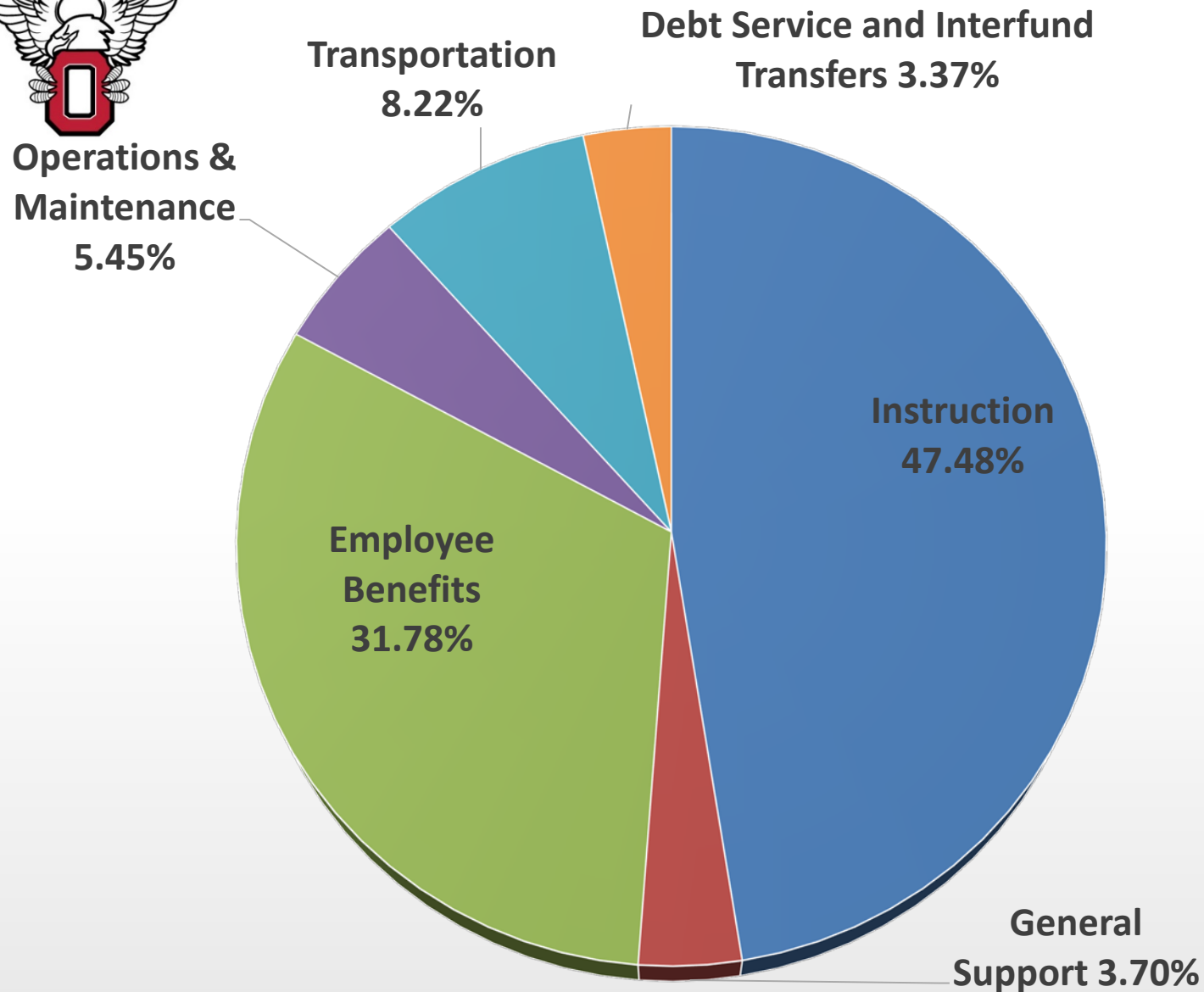
Proposed 2020-2021 Levy

(within the allowable levy limit)



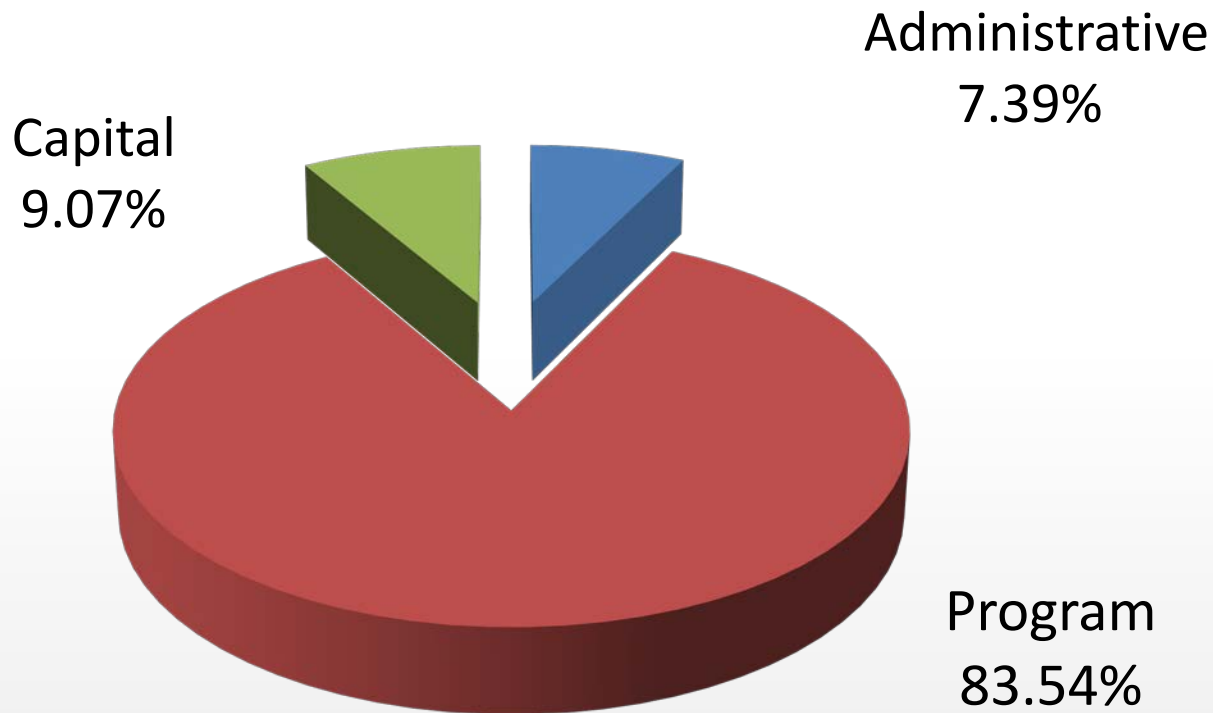

Capital Projects Funded with Budget

- » Bennett gymnasium rooftop air handling unit demolition and replacement - \$500,000
 - > Work to include a bid alternate that will include a new water heater which will be integrated into the existing building management system and will provide for an electric dishwasher booster heater
- » Paving/Tennis Courts - \$250,000

Contingency Budget

At this time, there is no guidance on a second vote.

Without guidance on a second vote, if the budget is defeated, then the District may be required to automatically go to a contingency budget.

In a contingent budget, the 2020-2021 tax levy would remain at the same level as the 2019-2020 school year.

Other contingency rules would apply:

- No purchase of equipment

- \$350,500 in recommended budget

- Administrative Component Cap

- Limited to % of Program budget as prior year

- Fees must be charged for Facilities Use

19-20 Tax Levy	\$44,758,538
20-21 Tax Levy Limit	\$43,640,790
20-21 Tax Levy at Contingency	\$43,640,790
Difference between Tax Levy Limit and Contingency	(\$1,117,748)

Ballot

- » Proposition #1
 - > \$57,938,452 Expenditure Budget
- » Voting for 3 Open Board Seats
 - > 3 year terms starting July 1, 2020
- » All voting will be done via absentee ballot
